## DOG LICENSE APPLICATION

## Certain Dogs Prohibited. The following dogs may not be kept within the City of Pine Lawn, Missouri: Section 1.

- (1) Any "pit bull dog" being defined to mean:
  - a. The bull terrier breed of dog
  - b. The Staffordshire bull terrier breed of dog
  - The American pit bull terrier breed of dog
  - The American Staffordshire breed of dog
  - Dog of mixed breed or other breeds than above listed which breed or mixed breed is known as pit bulls, pit bull dogs or pit bull terrier; or
  - Any dog which has the appearance and characteristics of being predominately of the breeds of bull terrier, Staffordshire bull terrier, American pit bull terrier, American Staffordshire terrier, any other breed commonly known as pit bulls, pit bull dogs or pit bull terriers, or a combination of any of these breeds.
  - Rottweiler breed, including dogs of mixed breed and any dog which has the appearance and characteristics of being predominately of the Rottweiler breed.

Punishment. The owner or keeper of any of the above defined dogs found within the city limits of the City of Pine Section 2. Lawn may be punished by a fine of up to One Thousand Dollars (\$1,000.00) and may be jailed for up to ninety (90) days or both Additionally, the dog or dogs shall be immediately confiscated by the Animal Control Officer of the City. If a violation of this Ordinance continues, each day's violation shall be deemed a separate violation.

- Conflicting Ordinances Repealed. All Ordinances or parts of Ordinances in conflict herewith are repealed. Section 3.
- This effective date of this Ordinance is August 15, 2007. Section 4.
- This Ordinance shall be in full force and effect from and after its passage. Section 5.

Section 210.270 Number of Dogs on Premises. It shall be unlawful for any person owning, controlling or possessing or having management or care in whole or in part of dogs, whether licensed or not, to keep more than two (2) dogs on the premises of the owner or keeper thereof at any one time, but such restrictions shall not apply to dogs less than three (3) months of age.

Any person having custody of or harboring a dog for fifteen (15) or more consecutive days shall be considered the owner of the dog and must make an application for a license.

Certificate of inoculation against rabies, signed by a licensed veterinarian must be presented with the application

Certificate of inoculation shall have been executed sometime during the pervious thirty-six (36) month period if a three (3) year type vaccine approved by the Director of Health or during a previous twelve (12) month period for all there vaccines

Application for a dog license shall be made and be made and the license obtained on or before April first (1st) of each year

License shall be obtain within sixty (60) days after the first of any animal born after April first (1)

The license tags issued shall be securely fastened on the collar or harness of the dog for which the license is issued and shall be worn at all times

Transfer of ownership of any dog must be reported to the City Clerk by the transferee within ten (10) days by written notice on forms supplied by the City Clerk, at which time the transferee shall pay to the City a transfer fee of twenty-five (\$0.25)

No license or tag shall be held by any person other than the one to whom the license or tag has been originally issued, except where a transfer of ownership takes place and is duly reported as provided in these regulations.
