## WEBSITE NOTICE

Due to the COVID-19 pandemic, all regularly scheduled municipal court dockets for the City of Pine Lawn are hereby **POSTPONED**. New court dates will be mailed in the near future. (If you have recently changed your address, please notify this Court by doing the following: calling (314) 261-9445.)

[While no entry into the courthouse is permitted], this Court can assist you with the following:

1. addressing warrants and bonds issued from this Court;
2. providing information about cases on the municipal dockets; and
3. making payments (for fines and court costs) to the municipal court.

Please call (314) 261-9445, between the hours of 9:00 a.m. and 5:00 p.m., Monday through Friday, for the above information. At all other times, when calling about warrants/bonds, please call the St. Ann at (314)428-6868 Police Department.

The following persons shall not enter a municipal courthouse:

- Persons who have traveled to any foreign country within the last 14 days;
- Persons who have traveled to states designated as “restricted” by the St. Louis County Department of Health, within the past 14 days. (For a current listing, see the St. Louis County Website: [www.stlcorona.com](http://www.stlcorona.com). Then click the “Update Travel List” button under “Areas of Community Transmission” on the right-hand side of the page.);
- Persons who reside or have had close contact with someone who has travelled to any foreign country or restricted area in the U.S. within the last 14 days;
- Persons who have been asked to self-quarantine by any doctor, hospital or health agency;
- Persons who have been diagnosed with, or have had contact with, anyone who has been diagnosed with COVID-19; and
- Persons with unexplained fever, cough or shortness of breath.

We appreciate your patience and cooperation during this time.

# PUBLIC NOTICE:

The following persons shall not enter the St. Louis County Courthouse, or any of its Municipal Divisions in St. Louis County Missouri:

- Persons who have traveled to any foreign country within the last 14 days;
- Persons who have traveled to states designated as "restricted" by the St. Louis County Department of Health within the last 14 days; (Please consult the St. Louis County Website at [www.stlcorona.com](http://www.stlcorona.com) under "Areas of Community Transmission.")
- Persons who travel to Illinois and stay overnight. This does not include individuals who live in Illinois and commute for work to St. Louis;
- Persons who reside or have had close contact with someone who has travelled to any foreign country or "restricted state" within the last 14 days;
- Persons who have been asked to self-quarantine by any doctor, hospital or health agency;
- Persons who have been diagnosed with, or have had contact with, anyone who has been diagnosed with COVID-19; and
- Persons with unexplained fever, cough or shortness of breath.

Anyone attempting to enter in violation of these protocols will be denied entry by a Court Security Officer. Effective March 16, 2020 per Administrative Order 14.
